2020 Kansas Presidential Primary

The Kansas Democratic Party is switching to a primary this year and using Ranked Choice Voting (RCV) to determine delegate distribution among the Presidential Democratic candidates. On September 6, 2019, the Republican Party announced that there will not be a Republican primary this year.

To be eligible to participate in the Democratic Kansas Presidential Primary, voters must be registered as a Democrat. Voters can change their party affiliation online or on the day of the primary. Kansans who are already registered will begin receiving their ballots with prepaid postage envelopes on March 30th.

From March 9 to March 17, newly registered Democrats can request mail-in ballots. April 24 is the post-mark deadline to return completed mail-in ballots. On

Primary Day, May 2, in-person voting occurs from 10 am - 4 pm. Same day registration is permitted.

Highlights of the Minutes LWV-L/DC Board Meeting February 11, 2020

Kristin called the meeting to order at 7:03 p.m. Kerry Altenbernd and Ursula Minor, representatives from the Lawrence/DG County Community Remembrance Coalition, presented information about the Equal Justice Initiative campaign to recognize local victims of lynching. Five members of Justice Matters initiated a discussion concerning the Douglas County Commission's recent proposal to take action on jail expansion that would involve issuing bonds without a public vote on the matter.

TREASURER: Melissa reported income of \$1,787.96 in January (dues \$870.81, contributions \$437.15, scholarship donations \$225, fundraising \$155, LWV Educ Fund \$100) and expenses of \$2,071.38 (\$100 Educ Fund pass through, \$1,090.40 board retreat, \$50 annual meeting space rental, \$31.48 VOTER printing, \$30 Kaw Valley event fee, \$769.50 state PMP).

Tracy moved and Marjorie seconded that the treasurer's report be accepted and filed for audit. Motion carried.

PRESIDENT: It was decided to table discussion about the board retreat until the March meeting. Kristin announced that the next MTP/Community Partnership meeting will be held Monday, March 23, 6:00 p.m. at the Keller Building Conference Room. Sonja Czarnecki has written a draft MTP Project Coordinator job description. Kristin will be a league representative

at the UN Commission on the Status of Women being held in New York City beginning March 9, 2020. She will have the opportunity to share her report from this meeting with other Lawrence organizations. VotER, an emergency room-based voter registration initiative would cost \$1200 to install at a hospital.

Our KU student league members have asked for help acquiring 15-20 t-shirts. It was suggested that KU be put on the front and the Centennial logo on the back. Becky Plate has submitted our PPFM report for January. Tamara will attend and report on future City Commission Strategic Planning meetings.

- We will vote on
 - Medical Indigence Position Statement Update
 - a possible new update to a Position Statement
 - Articles of Incorporation update (and hear about the 501(c)(3) conversion process)
- Centennial T-shirts will be available for purchase!

What's happening with the League position on Kan-Care Expansion?

All League positions, necessary for advocacy, are based on studies at the national, state or local level. This year the LWV-Kansas is updating the 1987 position on Medical Indigence. It will be submitted to the state board and, once approved, presented at the State League Council on Saturday April 25 in Emporia, KS.

Each Kansas League sent representatives to work on the state study. Marlene Merrill and Janice Friedman are representing our League. The LWVK Study Committee developed a position draft and a list of consensus questions for all Kansas Leagues to examine and evaluate. The committee then reviewed the recommendations and comments and developed the final draft position which follows:

[Revised Position as of 3/6/20] Health: Medical Indigence

BACKGROUND: The LWVK State Convention of 1987 adopted a state study of Medical Indigence in recognition of the serious need for basic health care availability. Details of the LWVUS position, "Access to Health Care," may be found in IMPACT ON ISSUES 2000-2002. This most recent Kansas update is adapted from the 2018-2020 LWV U.S. position on Health Care.* LWVUS announced its initial health care position in April 1992 and the final position in April 1993. The 2016 Convention updated the position by concurrence to include behavioral health.

STATEMENT OF POSITION: We define medical indigence based on 2018 Kansas Statute 65-7402. "Medically indigent person" means a person who lacks resources to pay for medically necessary health care services. This updated position addresses medical indigence by proposing that all residents should have access to affordable, high quality health care.

The League of Women Voters of Kansas believes that:

1. A basic level of quality health care at an affordable cost should be available to all Kansas residents.
2. A basic level of quality behavioral health care at an affordable cost should be available to all Kansas residents.
3. The ability of a patient to pay for services should not be a consideration in the allocation of health care resources.
4. Medicaid expansion under the Affordable Care Act provides an important step to address gaps in coverage for the medically indigent – people who lack resources to pay for medically necessary health care. LWV KS supports Medicaid Expansion in Kansas to cover individuals up to 138% of the Federal Poverty Level.
5. Other Kansas health care policy goals should include:
 - a. The equitable distribution of services,

- b. Efficient and economical delivery of care
- c. Adequate total state expenditure level for health care

BASIC LEVEL OF QUALITY HEALTH CARE: The League supports:

1. Every Kansas resident should have access to:
 - a. A basic level of care that includes the prevention of disease, health promotion and education, primary care (including prenatal and reproductive health), acute care, long-term care.
 - b. Affordable, quality dental, vision, and hearing care.

BASIC LEVEL OF BEHAVIORAL HEALTH: The League supports:

1. Behavioral health as the accepted term that includes both mental illness and substance use disorder.
2. Behavioral health care that is integrated with, and achieves parity with, physical health care.
3. In and out-patient behavioral health care, including needed medications and supportive service.
